1. Full payment of all invoices shall be made within 20 days of the date of invoice, or as otherwise printed on the invoice, whichever is sooner.
2. All sums due shall be paid in full without any set-off, deduction, counterclaim and/or any other withholding of monies.
3. Where invoices are not paid by the due date we shall be entitled to:
  - a. Refuse to supply further services and/or goods
  - b. Charge interest on the outstanding amount at the rate of 4% per annum above the base rate of Lloyds TSB Bank, accruing daily, until payment is received
  - c. Take immediate steps to recover outstanding monies, including interest and additional costs
4. Should any payment be made and subsequently dishonoured an additional fee of £25.00 shall become due.
5. We accept payment by cash, cheque, debit/credit card and BACS transfer.
